NOTES:

1. Ministry of Corporate Affairs ("MCA") vide its General Circular No. 03/2025 dated 22nd September, 2025, and circular issued by SEBI vide Circular no. SEBI/HO/CFD/CFDPoD-2/P/CIR/2024/133 dated October 3, 2024 ("SEBI Circular") and other circulars and notifications issued(including any statutory modifications or re-enactments thereof for the time being force and as amended from time to time, Companies are allowed to hold AGM through Video Conferencing ("VC") or through Other Audio-Visual Means ("OAVM"), without the physical presence of the Members at a common venue. In compliance with these Circulars, the 40th AGM of the Company is being conducted through VC/ OAVM facility, without the physical presence of Members at a common venue. The deemed venue for the 40th AGM shall be the Registered Office of the Company.
2. Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013 ('the Act'), Body Corporate members are entitled to appoint authorized representatives for participating in the 40th AGM through VC / OAVM facility and cast their votes through e-Voting.
3. The Members can join the 40th AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available to at least 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc., who are allowed to attend the AGM without restriction on account of first come first served basis.
4. The attendance of the Members attending the 40th AGM through VC / OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act 2013. Since the AGM will be held through VC / OAVM facility, Proxy Form, Attendance Slip including the Route Map is not annexed to this Notice.
5. In accordance with the MCA Circulars and Regulation 36(1)(a) of the SEBI Listing regulations, notice of the 40th AGM along with the Annual Report for the Financial Year (F.Y.) 2025-26 is being sent by electronic mode to those Members whose e-mail ids are registered with the Company or the Depository Participants (DPs). The Notice and Annual Report for the Financial Year (F.Y.) 2025-26 is also available on the Company's website i.e. www.burnpurcement.com, website of the Bombay Stock Exchange at www.bseindia.com and on the website of National Stock Exchange of India Limited at www.nseindia.com and at NSDL at www.evoting.nsdl.com.
6. Members seeking any information with regard to the accounts or any matter to be placed at the AGM, are requested to write to the Company on or before 15th September, 2026 through email on cs@burnpurcement.com. The same will be replied by the Company suitably.
7. Pursuant to the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations') and the Circulars issued by the MCA dated April 08, 2020, April 13, 2020 and May 05, 2020, the Company is providing facility of remote e-voting to its Members in respect of the businesses to be transacted at the AGM. For this purpose, the Company has entered into an agreement with National Securities Depository Limited ('NSDL') for facilitating voting through electronic means, as the authorized e-Voting agency. The facility of casting votes by a member using remote e-Voting as well as the e-Voting system on the date of the AGM will be provided by NSDL.
8. Only registered members of the Company may attend and vote at the meeting as provided under the provisions of the Act. Further, members who have cast their vote by remote e-Voting prior to the Meeting may attend the Meeting but shall not be entitled to cast their vote again

9. In case of joint holders attending the meeting, the member whose name appears as the first holder in the order of names as per the Register of Members of the Company will be entitled to vote for the purposes of the AGM.
10. The Register of Contracts or Arrangements in which Directors are interested, maintained under Section 189 of the Act, the Register of Directors and Key Managerial Personnel and their shareholding, maintained under Section 170 of the Act read with Rules made thereunder will be available for inspection at the AGM.
11. The physical copy of the Notice along with Annual Report shall be made available to Member(s) who may request for the same in writing to the Company at cs@burnpurcement.com.
12. The Register of Members and Share Transfer Books of the Company shall remain closed from 16th September, 2026 to 22nd September, 2026 (both days inclusive) for annual closing.
13. Members holding Shares of the Company in physical form through multiple folios in identical names or joint accounts in the same order of names are requested to consolidate their shareholding into single folio, by sending their original share certificates along with a request letter to consolidate their shareholding into one single folio, to the Registrar & Share Transfer Agent ('RTA') of the Company i.e. M/s Niche Technologies Private Limited.
14. In all correspondence with the Company/RTA, members holding shares in physical form are requested to quote their Folio Number and in case their shares are held in the dematerialized form, they must quote their DP ID and Client ID Number.
15. To support "Green initiative", Members who have not registered their e-mail address so far, are requested to register their e-mail address for receiving all communications from the Company electronically.
16. Members holding shares in physical form are requested to intimate change in their registered address mentioning full address in block letters with Pin code of the Post office, mandate, bank particulars and Permanent Account Number (PAN) to the Company's RTA and in case of members holding their shares in electronic form, this information should be given to their Depository Participants immediately.

Members holding shares in demat form may contact their respective Depository Participant for recording Nomination in respect of their shares.
18. Members may please note that SEBI vide its Circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/ CIR/2022/8 dated January 25, 2022 has mandated the Listed Companies to issue securities in demat form only while processing service requests viz. Issue of duplicate securities certificate; claim from Unclaimed Suspense Account; Renewal/ Exchange of securities certificate; Endorsement; Sub-division/ Splitting of securities certificate; Consolidation of securities certificates/ folios; Transmission and Transposition. Accordingly, Shareholders are requested to make service requests by submitting a duly filled and signed Form ISR – 4, the format of which is available on the Company's website at www.burnpurcement.com. Members holding equity shares of the Company in physical form are requested to kindly get their equity shares converted into demat / electronic form to get inherent benefits of dematerialisation.
19. Pursuant to the SEBI Circular no. SEBI/HO/MIRSD/MIRSDPoD1/P/CIR/2023/37 dated March 16, 2023 issued in super session of earlier circulars issued by SEBI bearing nos. SEBI/HO/MIRSD/



MIRSDRTAMB/P/CIR/2021/665 and SEBI/HO/MIRSD/MIRSDRT AMB/P/CIR/2021/687 dated November 3, 2021 and December 14, 2021, respectively, SEBI has mandated the listed Companies to have PAN, KYC, bank details and Nomination of all shareholders holding shares in physical form.

The Investor service requests forms for updation of PAN, KYC Bank details and Nomination viz. Forms ISR-1, ISR-2, ISR-3, SH-13, SH-14 and the said SEBI circular are available on our website at www.burnpurcement.com. In view of the above we urge the shareholders to submit the Investor Service Request form along with the supporting documents at the earliest.

20. Voting through electronic means

Pursuant to the provisions of Section 108 and other applicable provisions, if any, of the Act and the Companies (Management and Administration) Rules, 2014, as amended and Regulation 44 of SEBI Listing Regulations, the Company is pleased to provide to its members the facility to exercise their right to vote on resolutions proposed to be passed in the AGM by electronic means. The members may cast their votes using an electronic voting system from a place other than the venue of the Meeting ('remote e-voting').

Members of the Company holding shares either in physical or in dematerialized form as on the cut-off date i.e., 15th September, 2026 and not casting their vote electronically during e-voting period may cast their vote electronically at the time of AGM.

The members who have cast their vote by remote e-voting may also attend the Meeting but shall not be entitled to cast their vote again.

Any person, who acquires shares of the Company and becomes a member of the company after dispatch of the Notice of the AGM and holding shares, as of the cut-off date, i.e., 15th September, 2026 may obtain the login ID and password by sending request at (cs@burnpurcement.com and evoting@nsdl.com). However, if you are already registered with NSDL for remote e-voting then you can use your existing User ID and password for casting your vote.

The company has entered into an arrangement with NSDL, the Depository of the Company for facilitating e-voting, through their e-voting platform (<https://www.evoting.nsdl.com/>).

THE INSTRUCTIONS FOR MEMBERS FOR REMOTE E-VOTING AND JOINING ANNUAL GENERAL MEETING ARE AS UNDER:-

The remote e-voting period begins on 19th September, 2026 at 9:00 A.M. and ends on 21st September, 2026 at 5:00 P.M. The remote e-voting module shall be disabled by NSDL for voting thereafter. The Members, whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. 15th September, 2026, may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being 15th September, 2026.

How do I vote electronically using NSDL e-Voting system?

The way to vote electronically on NSDL e-Voting system consists of "Two Steps" which are mentioned below:

Step 1: Access to NSDL e-Voting system

- A) Login method for e-Voting and joining virtual meeting for Individual shareholders holding securities in demat mode

In terms of SEBI circular dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

How to Log-in to NSDL e-Voting website?

1. Visit the e-Voting website of NSDL. Open web browser by typing the following URL: <https://evoting.nsdl.com/> either on a Personal Computer or on a mobile.
2. Once the home page of e-Voting system is launched, click on the icon "Login" which is available under 'Shareholder/Member' section.
3. A new screen will open. You will have to enter your User ID, your Password/OTP and a Verification Code as shown on the screen.

- 6. If you are unable to retrieve or have not received the "Initial password" or have forgotten your password:
 - a) Click on "Forgot User Details/Password?" (If you are holding shares in your demat account with NSDL or CDSL) option available on www.evoting.nsdl.com.
 - b) Physical User Reset Password?" (If you are holding shares in physical mode) option available on www.evoting.nsdl.com.

- 7. After entering your password, tick on Agree to "Terms and Conditions" by selecting on the check box.
- 8. Now, you will have to click on "Login" button.
- 9. After you click on the "Login" button, Home page of e-Voting will open.

Step 2: Cast your vote electronically and join General Meeting on NSDL e-Voting system.

How to cast your vote electronically and join General Meeting on NSDL e-Voting system?

- 1. After successful login at Step 1, you will be able to see all the companies "EVEN" in which you are holding shares and whose voting cycle and General Meeting is in active status.
- 2. Select "EVEN" of company for which you wish to cast your vote during the remote e-Voting period and casting your vote during the General Meeting. For joining virtual meeting, you need to click on "VC/OAVM" link placed under "Join Meeting".
- 3. Now you are ready for e-Voting as the Voting page opens.
- 4. Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on "Submit" and also "Confirm" when prompted.
- 5. Upon confirmation, the message "Vote cast successfully" will be displayed.
- 6. You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
- 7. Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

General Guidelines for shareholders

1. Institutional shareholders (i.e. other than individuals, HUF, NRI etc.) are required to send scanned copy (PDF/JPG Format) of the relevant Board Resolution/ Authority letter etc. with attested specimen signature of the duly authorized signatory(ies) who are authorized to vote, to the Scrutinizer by e-mail to nupur.mimani7@gmail.com with a copy marked to evoting@nsdl.com Institutional shareholders (i.e. other than individuals, HUF, NRI etc.) can also upload their Board Resolution / Power of Attorney / Authority Letter etc. by clicking on “**Upload Board Resolution / Authority Letter**” displayed under “**e-Voting**” tab in their login.
2. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential. Login to the e-voting website will be disabled upon five unsuccessful attempts to key in the correct password. In such an event, you will need to go through the “[Forgot User Details/Password?](#)” or “[Physical User Reset Password?](#)” option available on www.evoting.nsdl.com to reset the password.
3. THE INSTRUCTIONS FOR MEMBERS FOR e-VOTING ON THE DAY OF THE AGM ARE AS UNDER:-

1. The procedure for e-Voting on the day of the AGM is same as the instructions mentioned above for remote e-voting.
2. Only those Members/ shareholders, who will be present in the AGM through VC/OAVM facility and have not casted their vote on the Resolutions through remote e-Voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system in the AGM.



3. Members who have voted through Remote e-Voting will be eligible to attend the AGM. However, they will not be eligible to vote at the AGM.
4. The details of the person who may be contacted for any grievances connected with the facility for e-Voting on the day of the AGM shall be the same person mentioned for Remote e-voting.

INSTRUCTIONS FOR MEMBERS FOR ATTENDING THE AGM THROUGH VC/OAVM ARE AS UNDER :

TRANSFER TO RESERVE

During the year under review the Company has incurred losses, therefore, no fund is available to transfer into reserve.

DIVIDEND

The company has incurred losses during the year under review, therefore, your Directors do not recommend any dividend for the financial year ended 31st March, 2026.

STATE OF COMPANY'S AFFAIRS

The Company was classified as NPA back in December 2016. Your Company was taken into the securitization process by its secured financial creditor i.e. State Bank of India and Central Bank of India under Securitisation and Reconstruction of Financial Assets and Enforcement of Securities Interest Act, 2002 (SARFAESI Act). State Bank of India and Central Bank of India in the year 2019, had assigned their debts (approx. 76% of the total secured financial debt) to M/s UV Asset Reconstruction Company Limited (UVARCL), an Asset Reconstruction Company (ARC) under the SARFAESI Act, 2002 through swiss challenge method and accordingly the loan account was assigned from SBI and CBI to UVARCL in the books of the Company. Further in August 2022, UVARCL acquired the remaining 24% financial debt of the Company from its secured financial creditor (Formerly known as United Bank of India), Punjab National Bank under SARFAESI Act, 2002 resulting in acquisition of 100% financial debt of the Company by UVARCL.

The Company had major three assets in its Books of Accounts, one asset (Land, Building and operational Plant & Machinery) in Patratu, Jharkhand and others two non-operational assets in Asansol i.e. Mauza Dharma (10.7 acres) and second is Palasdiha land (6.535 acres). These two immovable properties

situated at Mauza Dharma (8.03 acres) and Palasdiha were sold by UVARC Limited (Financial Creditor of the Company) under Security Interest (Enforcement) Rules, 2002 for Rs. 5,52,00,000/- and Rs. 14,53,00,000/- respectively in the year 2022. The plant & machinery of the Asansol unit was sold by WBFC against their outstanding loan in the year 2020 for an amount of Rs. 30,00,000.

In the financial year 2023-2024, UVARCL (Financial Creditor) under the SARFAESI Act, 2002 sold the Immovable and Movable Assets of the Patratu Plant in Jharkhand through an auction process to M/s Ultratech Cement Limited on November 29, 2023.

At present, the Financial Creditor has sold all the assets which were the only source of generating revenue and the Company does not have any alternative source of Income.

During the Financial Year ended 31st March 2026, the Company did not carry any business operations and as a result, generated no revenue. The Company remained non-operational throughout the year and there were no significant changes in the state of affairs of the Company during the year under review.

CHANGE IN THE NATURE OF BUSINESS

During the year under review, there was no change in the nature of the business of the Company.

MATERIAL CHANGES AND COMMITMENTS

The Paid-up Share capital of the Company has been reduced from Rs. 86,12,43,630 divided into 8,61,24,363 Equity Shares of Rs. 10 each, fully paid-up, to Rs. 17,22,48,730 divided into 1,72,24,873 Equity Shares of Rs. 10 each, fully paid-up in the last financial year, pursuant to the duly approved scheme of arrangement by the Hon'ble Bench of the National Company Law Tribunal (NCLT), Kolkata. Post reduction of Share capital of the Company, the process of corporate action has been completed and Listing approval from NSE and BSE has also been received for the above equity shares during the year under review. Accordingly, the Company has applied for trading approval of the above said shares which are likely to receive soon from both the Stock Exchange i.e. NSE and BSE.

DETAILS OF SIGNIFICANT AND MATERIAL ORDERS PASSED BY THE REGULATORS OR COURTS OR TRIBUNALS

During the year under review there was no any significant order passed by the Regulators or Courts or Tribunal.

MANAGEMENT DISCUSSION & ANALYSIS

Industry Structure & Developments

India is the second-largest cement producer in the world. The global cement industry's installed capacity was 5.2 billion tons. Out of total capacity India's installed capacity lies 650 million metric tons with a production of 450 – 470 million metric tons.

The Indian cement industry continued to witness healthy demand during FY 2025–26, supported by sustained investments in infrastructure, housing and commercial construction. Industry estimates indicate cement demand growth of around 6–8% during the year, with continued capacity additions by major manufacturers to meet the increasing demand. During FY 2025–26, the cement industry witnessed moderate capacity utilization levels in the range of approximately 70%–72%, reflecting continued capacity additions by major manufacturers and regional demand variations. While utilization levels remained relatively higher in the northern and central regions, certain surplus regions, particularly the southern region, continued to operate at comparatively lower utilization levels owing to excess installed capacity and competitive market conditions.

During FY 2025–26, demand for cement was primarily driven by continued investments in infrastructure, housing and commercial construction. Government expenditure on roads, railways, urban infrastructure and affordable housing remained the key growth catalyst for the industry. Demand growth, however, moderated during the year owing to uneven execution of certain infrastructure projects and normal cyclical trends in the real estate sector.

The distribution of cement production capacity across India's region is as follows:

Southern India: Approximately 31% of total Capacity. This region benefits from abundant limestone deposits, particularly in states like Andhra Pradesh, Tamil Nadu, Telangana and Karnataka.

Northern India : Around 21% of total Capacity. Notable states are Rajasthan, Punjab, and Haryana.

Eastern India : Approximately 19% of total Capacity. Key States include West Bengal, Chhattisgarh, Odisha and Jharkhand.

Western India : Around 17% of total capacity. This includes Gujrat, and Maharashtra

Central India : Approximately 12% of the capacity. States like Madhya Pradesh and Uttar Pradesh are prominent in this region.

India's continued economic growth and rapid urbanization are expected to support sustained demand for cement over the medium to long term. Rising urban migration, coupled with increasing investments in residential housing, transportation infrastructure, healthcare, educational institutions and other urban infrastructure, continues to drive construction activity and cement consumption across the country.

The Indian cement industry is projected to grow at a CAGR of 4.9% from 2024 to 2029, with cement production expected to reach around 509 million tons by FY2028–29 supported by sustained demand from infrastructure, housing and commercial construction. The housing segment, accounting for nearly 55% of domestic cement consumption, continues to be the largest demand driver, with steady growth expected from both rural housing and urban real estate projects. In addition, the Government's continued focus on affordable housing, transport infrastructure, smart cities and other public infrastructure projects is expected to provide sustained support to cement demand and capacity utilization across the industry.

Opportunity & Threats

The Indian cement industry is well-positioned for long-term growth, supported by abundant limestone reserves and sustained expansion in construction and infrastructure activities. Continued government focus on infrastructure development, including roads, railways, logistics networks and urban infrastructure, is expected to drive significant cement demand over the medium to long term.

The growing housing sector, which typically accounts for 55% to 60% of India's cement consumption, will also continue to remain a key demand driver supported by sustained demand from both rural housing and urban residential construction.

The Union budget 2026 has laid out a visionary roadmap for India's economic growth, with a strong emphasis on national infrastructure development including Railways, Roadways and coastal.

The Union Budget 2026 continues to prioritize infrastructure development as a key pillar of economic growth, with emphasis on railways, road transport and coastal infrastructure. These initiatives are expected to support sustained capital expenditure and drive demand across core sectors, including cement.

Initiatives such as the Pradhan Mantri Gati Shakti National Master Plan, aimed at developing multimodal connectivity, along with the Smart Cities Mission and AMRUT programme, are contributing to infrastructure development and urban transformation in the country. These initiatives are expected to support increased cement consumption through sustained investments in transport infrastructure, urban development and civic amenities.

The cement sector is a significant contributor to global greenhouse gas (GHG) emissions, accounting for approximately 7% of global CO₂ emissions. This is primarily attributable to the energy-intensive nature of cement manufacturing, which involves high-temperature processing of limestone and other raw materials.

In India, the industry is increasingly focused on reducing its environmental footprint through the adoption of energy-efficient technologies, use of alternative fuels, clinker optimisation and increased use of blended cements.

On the other hand, the Indian Cement Industry faces several challenges that could impact profitability and growth. Key threats include:

Declining Cement Prices : The Indian cement industry continues to face certain challenges that may impact profitability and growth. During FY 2025–26, the industry witnessed pricing pressure due to intense competition and regional supply-demand imbalances.

In addition, volatility in input costs such as energy, fuel and transportation, along with fluctuations in demand and evolving regulatory requirements, may continue to affect industry margins and overall profitability.

Slower Demand Growth : The cement industry may witness moderation in demand growth during FY 2025–26, driven by a slower pace of construction activity in certain regions, delays in infrastructure project execution, and cyclical softness in housing and real estate demand. This could impact capacity utilization levels and pricing dynamics across the industry.

Rising Input Costs : The cement industry remains exposed to volatility in input costs, particularly in fuel (coal/pet coke), power, raw materials and freight. During FY 2025–26, fluctuations in global energy prices and transportation costs may continue to exert pressure on operating margins across the industry.

Intensified Competition and Overcapacity : The cement sector is characterized by intense competition and structural overcapacity in certain regions, leading to pricing pressure and variability in capacity utilization. During FY 2025–26, the addition of new capacities and regional supply-demand imbalances may further intensify competitive pressures across markets.

Logistics and Infrastructure Constraints : Logistics constraints and fluctuations in freight and transportation costs may impact dispatch efficiency and overall profitability, given the high transportation intensity of the cement industry. Cement being a bulk commodity with low value-to-weight ratio requires efficient road and rail connectivity for cost-effective movement across regions. Any disruptions in transportation networks, fuel price volatility, or capacity constraints in rail and road infrastructure may affect timely delivery, distribution efficiency, and operating margins of industry participants.

Regulatory and Environmental Compliance Risk : Increasing environmental regulations and sustainability requirements may result in higher compliance costs and capital expenditure on cleaner technologies and emission reduction initiatives.

Segment wise, Financial and Operational Performance

Since January, 2017, your Company operates in Single Segment i.e. Cement Segment.

Your Company has discontinued its operation w.e.f. November 2023, after incurring continuous losses. Further, the Company has experienced significant liquidity constraints and has been unable to meet its financial obligations as and when they fall due. Based on the above facts and circumstances, The



Company's management has assessed the Company's ability to continue as a going concern and has concluded that it is not reasonably likely to meet its obligations in the normal course of business over the next 12 months as Company do not have any functional production unit and significant assets, as the Financial Creditor has sold all the assets which were the only source of generating revenue and the Company does not have any alternative source of Income. These conditions have resulted in significant uncertainty regarding the Company's ability to continue its operations in the normal course of business.

Notwithstanding the above, the management has informed the Board of Directors that it continues to explore and evaluate various strategic alternatives, including mergers, acquisitions, strategic partnerships, restructuring initiatives, and infusion of funds, with the objective of reviving the Company's business operations and restoring its financial stability.

Future Outlook

The outlook for the Indian cement industry in FY 2025–26 reflects a period of moderate growth supported by sustained infrastructure development, housing demand and continued capacity expansion.

Cement demand is expected to grow at approximately 4–5% year-on-year, reaching around 445–450 million metric tonnes (MT). This moderation reflects a temporary slowdown in construction activity in certain periods and the impact of adverse weather conditions in parts of the country.

The industry is expected to witness continued capacity additions of around 70–75 million MT over FY 2025–26, with a significant portion expected to come on stream during FY 2026. As a result, capacity utilization levels are likely to remain moderate at around 70–71%, given the pace of new capacity additions.

Companies are focusing on renewable energy adoption and green cement technologies to reduce carbon footprints. Innovations in green cement production methods, such as utilizing electric arc furnaces powered by renewable energy to recycle cement from demolished buildings, are emerging as potential game-changers.

In the medium to long term, cement-intensive infrastructure development is expected to play a key role in supporting India's economic growth. Continued investments in infrastructure are likely to contribute to sustained GDP growth and improvement in living standards, supported by a rising population and ongoing urbanization.

The Government's continued focus on infrastructure development is expected to require strong and stable revenue streams to support sustained public investment in building a modern economy. The cement industry, being a key input sector for infrastructure and construction, contributes meaningfully to economic activity and government revenues.

Further, India's focus on initiatives such as 'Make in India' and attracting foreign direct investment (FDI) is expected to benefit from the cement sector's long-term growth potential. Given the need for cement manufacturing to remain close to demand centres, the sector is likely to continue attracting investments in line with infrastructure development and regional consumption patterns.

Risk & Concern

I. To meet projected long-term demand, the Indian cement industry will require significant capacity additions over the coming years. This will entail investments in new plants, acquisition of land, securing raw material linkages, and availability of skilled manpower. Any delay or shortfall in planned investments may impact the industry's ability to meet future demand effectively.

II. The cement industry is influenced by changes in government policies and regulatory frameworks, including taxation, environmental norms and construction-related regulations such as RERA and GST. In addition, restrictions on sand mining and other construction materials may impact construction activity and, consequently, cement demand.

III. The industry remains exposed to volatility in input costs, including fuel, energy, raw materials, freight and logistics. Fluctuations in global crude oil prices, duties and taxes may further increase production costs. In a highly competitive market with excess capacity, the ability to fully pass on cost increases to customers may remain limited, thereby impacting margins.

IV. The cement industry is energy-intensive and contributes significantly to carbon emissions. Increasing focus on environmental sustainability, carbon reduction targets and potential regulatory mechanisms such as carbon pricing may require additional investments in cleaner technologies and alternative fuels to reduce emissions intensity.

V. With increasing reliance on digital systems and automation, the industry is exposed to cybersecurity risks, including data breaches, system disruptions and potential operational impacts. Strengthening IT infrastructure and cybersecurity frameworks remains critical to ensure business continuity and data protection.

Internal control system and its adequacy

Your Company has in place an adequate system of internal controls, with documented procedures covering all corporate functions and its operating units. Systems of internal controls are designed to provide reasonable assurance regarding the effectiveness and efficiency of operations, the adequacy of safeguards for assets, the reliability for financial controls, and compliance with applicable laws and regulations. Adequate internal control measures are in the form of various policies and procedures issued by the Management covering all critical and important activities viz. Revenue Management, Operations, Purchase, Finance, Human Resources, Safety, etc. Adequate measures are taken from time to time to monitor energy efficiencies, safety and security as well as the hygiene standards maintained in the plant and corporate office. During the financial year, the standard terms of reference for Internal Audit which defines the framework for conduct of Internal Audits was updated incorporating latest changes to regulatory requirements and the evolving business context. Moreover, the Audit Committee of the Board reviews the findings of the Internal Auditor and closely monitors the implementation of their recommendations by reviewing the compliance reports furnished.

The interest coverage is -34.81 times however it was -135.71 times during previous financial year, it shows positive change by 74 %. The reason being negative ratio is Nil revenue generated by the company during the entire financial year as Company's do not have any operational unit at present however interest is being charged on Secured loan on cumulative basis.

Current Ratio:

The Current ratio for the year is 0.002 times as compared to previous year of 0.003 times. The ratio is almost same as compared to the previous financial year. The reason for non-ideal ratio is the impact of finance (Interest) charges of Rs 7702.51 lacs on cumulative basis and the repayment schedule is nil.

Debt Equity Ratio:

The Debt equity ratio for the year is -0.98 times remain unchanged in comparison to the previous financial year. It shows constant increase of debt by 16% and whereas constant decrease of Shareholders fund by 16 % in information to the previous financial year. Debt has increased mostly due to Interest implication and to maintain fixed and day to day expenses.

Regulation 33(3)(d) of SEBI (LODR) Regulations, 2015: The Company experienced a delay of 38 days in the submission of the annual audited standalone financial results for the financial year ended March 31, 2025. The delay occurred due to the resignation of the statutory auditors, M/s. Agarwal HP & Associates, Chartered Accountants, on May 27, 2025, citing inability to complete the audit for the said financial year. As a result, the financial results could not be submitted within the prescribed statutory timeline. Monetary penalties were imposed by NSE and BSE; however, the same were subsequently waived upon submission of a representation by the Company citing genuine reasons for the delay.
 - iv. Regulation 17(1A) of SEBI (LODR) Regulations, 2015: The Company re-appointed a Non-Executive Director, namely Mrs. Poonam Srivastava (DIN: 08576000), who had attained the age of above 75 years, without obtaining prior approval of the shareholders as required under the Regulations. In this regard, monetary penalties were initially imposed by NSE and BSE. However, considering that the management of the Company had been taken over by UV Asset Reconstruction Company Ltd. (UVARCL) under the provisions of the SARFAESI Act, and in view of the overriding effect of the said Act, the stock exchanges subsequently reversed the fines.
 - v. Two shareholders, namely Mr. Shehul Sandip Parish and Ms. Rakhi Parikh, have submitted applications for reclassification from the "Promoter/Promoter Group" category to the "Public" category under Regulation 31A of SEBI (LODR) Regulations, 2015, which were considered by the Board in its meeting held on 19th January, 2026.
 - vi. The Company has, in one instance, filed Form with Registrar of companies with a delay, along with payment of additional fees, under the provisions of the Companies Act, 2013.

I. Report on the Audit of the Financial Statements

1. Opinion

- A. We have audited the accompanying financial statements of Burnpur Cement Limited (hereinafter referred to as "the Company"), which comprise the Balance Sheet as at 31 March 2026, and the Statement of Profit and Loss (including other comprehensive income), Statement of Changes in Equity and Statement of Cash Flows for the year then ended, and notes to the financial statements, including a summary of the significant accounting policies and other explanatory information (hereinafter referred to as "the financial statements").
- B. In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at 31 March 2026, and its loss and other comprehensive income, changes in equity and its cash flows for the year ended on that date.

2. Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under Section 143(10) of the Act. Our responsibilities under those SAs are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence obtained by us is sufficient and appropriate to provide a basis for our opinion on the financial statements.

3. Key Audit Matters

- A. Key audit matters ('KAM') are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.
- B. We have determined that there are no key audit matters to communicate in our report.

4. Emphasis of Matters Paragraph

- A. The Company has discontinued its operation in entirety w.e.f. November 2023 after incurring continuous losses. These factors have raised significant doubts on the ability of the Company to continue as a "Going Concern". The management of the Company has ascertained that the Company is not a Going Concern. The necessary adjustments required on the carrying amount of assets and liabilities are not ascertainable at this stage.
- B. The financial statement includes Cash in hand aggregating to Rs. 22.90 lakhs pertaining to Asansol Unit, lying as Cash in Hand for more than 3 years. This cash is lying idle and not being used by the Company. The entire immoveable and moveable assets of the Company situated at Patratu has been sold and the Company does not have any operational unit as on 31.03.2026.
- C. The Company is involved in several ongoing direct and indirect tax litigations. The impact of the same is not ascertainable at present.

5. Information Other than the Financial Statements and Auditor's Report Thereon

- A. The Company's Board of Directors is responsible for the other information. The other information comprises the information included in the Company's annual report, but does not include the financial statements and our auditors' report thereon.

- B. Our opinion on the financial statements does not cover the other information and we will not express any form of assurance conclusion thereon.
- C. In connection with our audit of the financial statements, our responsibility is to read the other information identified above when it becomes available and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report other than the matters mentioned above.

6. Responsibilities of Management for The Financial Statements

- A. The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Act with respect to the preparation of these financial statements that give a true and fair view of the state of affairs, profit/ loss and other comprehensive income, changes in equity and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Indian Accounting Standards (Ind AS) specified under Section 133 of the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.
- B. In preparing the financial statements, the Board of Directors is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.
- C. Those Board of Directors are also responsible for overseeing the Company's financial reporting process.

7. Auditor's Responsibilities for the Audit of the Financial Statements

- A. NOTES FORMING PART OF THE FINACIAL STATEMENT

1. COMPANY INFORMATION

Burnpur Cement Limited ("the company") is a public limited company incorporated in India with its registered office in Kolkata, India. The Company is listed on the Bombay Stock Exchange (BSE) and the National Stock Exchange (NSE). The company is primarily engaged in manufacturing of Cement and had manufacturing facilities located in Jharkhand upto 29th Nov, 2023. On November 29, 2023, M/s UV Asset Reconstruction Company Limited ('UVARCL'), by exercising their powers conferred to them under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 read with Security Interest (Enforcement) Rules, 2002, had by an auction process sold the entire immoveable and moveable assets of the Company situated at Patratu, Jharkhand to M/s Ultratech Cement Limited, hence at present Company do not have any manufacturing or operational unit.

2. MATERIAL ACCOUNTING POLICIES

This note provides a list of the material accounting policies adopted in the preparation of these Indian Accounting Standards (Ind-AS) financial statements. These policies have been consistently applied to all the years.

2.1 STATEMENT OF COMPLIANCE AND BASIS OF PREPARATION

These financial statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 (as amended from time to time) and presentation and disclosure requirements of Division II of Schedule III to the Companies Act, 2013, (Ind AS compliant Schedule III) as amended. These standalone financial statements are presented in INR and all values are rounded to the nearest lacs (INR 00,000), except when otherwise indicated. The company's management has assessed the company's ability to continue as a going concern and the financial statement of the company has been prepared on the assumption that the company is not a going concern. The impact is not ascertainable at present.

Non-Going Concern Basis

The financial statements have not been prepared on a going concern basis due to the following indicators of material uncertainty:

- Continuous operating losses
- Negative net worth
- Inability to meet financial obligations as and when they fall due
- Discontinuation of manufacturing activities

2.2 USE OF ESTIMATES AND CRITICAL ACCOUNTING JUDGEMENTS

In preparing the financial statements on a non-going concern basis, management has made significant estimates and judgments regarding the recoverable value of assets, timing and amounts of liabilities, and expected manner of realization/settlement. These estimates involve significant uncertainty due to the nature of the non-going concern situation.

2.3 PROPERTY, PLANT AND EQUIPMENT

The cost of an item of property, plant and equipment is being recognized as an asset if it are probable that the future economic benefits associated the item will flow to the Company and its cost can be measured reliably. This recognition principle is applied to the costs incurred subsequently to add to, replace part of or service it. All other repair and maintenance costs, including regular servicing, are recognized in the statement of profit and loss as incurred. When a replacement



occurs, the carrying amount of the replaced part is derecognized. Where an item of property, plant and equipment comprises major components having different useful lives, these components are accounted for as separate items. The gain or loss arising on disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset, and is recognized in the statement of profit and loss.

2.4 DEPRECIATION & AMORTIZATION OF PROPERTY, PLANT AND EQUIPMENT AND INTANGIBLE ASSETS.

Depreciation or amortization is provided so as to write off, on a straight-line basis, the cost of property, plant and equipment and other intangible assets to their residual value. Depreciation on Property, Plant and equipment is provided on straight line method, according to the useful life of the asset as prescribed in schedule II of the Companies Act, 2013. Intangible Assets such as patents, trademarks, software are amortized based upon their estimated useful life of 6 years.

2.5 IMPAIRMENT

At each balance sheet date, the Company reviews the carrying values of its property, plant and equipment and intangible assets to determine whether there is any indication that the carrying value of those assets may not be recoverable through continuing use. If any such indication exists, the recoverable amount of the asset is reviewed in order to determine the extent of impairment loss (if any). An impairment loss is recognised in the statement of profit and loss as and when the carrying value of an asset exceeds its recoverable amount. Where an impairment loss subsequently reverses, the carrying value of the asset (or cash generating unit) is increased to the revised estimate of its recoverable amount so that the increased carrying value does not exceed the carrying value that would have been determined had no impairment loss been recognised for the asset (or cash generating unit) in prior years. A reversal of an impairment loss is recognised in the statement of profit and loss immediately. There is no impairment loss during the financial year.

2.6 LEASES

The Company determines whether an arrangement contains a lease by assessing whether the fulfilment of a transaction is dependent on the use of a specific asset and whether the transaction conveys the right to use that asset to the Company in return for payment. Where this occurs, the arrangement is deemed to include a lease and is accounted for either as finance or operating lease.

Leases are classified as finance leases where the terms of the lease transfers substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

The Company as lessee

- (i) **Operating lease** – Rentals payable under operating leases are charged to the statement of profit and loss on a straightline basis over the term of the relevant lease unless another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed. Contingent rentals arising under operating leases are recognised as an expense in the period in which they are incurred. In the event that lease incentives are received to enter into operating leases, such incentives are recognised as a liability. The aggregate benefit of incentives is recognised as a reduction of rental expense on a straight line basis, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed.

2.7 FINANCIAL INSTRUMENTS

Financial assets and financial liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument. Financial assets and liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit and loss) are added to or deducted from the fair value measured on initial recognition of financial

asset or financial liability. The transaction costs directly attributable to the acquisition of financial assets and financial liabilities at fair value through profit and loss are immediately recognised in the statement of profit and loss.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial instrument and of allocating interest income or expense over the relevant period. The effective interest rate is the rate that exactly discounts future cash receipts or payments through the expected life of the financial instrument, or where appropriate, a shorter period.

(a) Financial assets

Cash and bank balances

Cash and bank balances consist of :

- (i) Cash and cash equivalents - which includes cash in hand, deposits held at call with banks and other short term deposits which are readily convertible into known amounts of cash, are subject to an insignificant risk of change in value and have maturities of less than one year from the date of such deposits.
- (ii) Other bank balances

Financial assets at amortised cost

Financial assets are subsequently measured at amortised cost if these financial assets are held within a business model whose objective is to hold these assets in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. The Company in respect of equity investments (other than in subsidiaries, associates and joint ventures) which are not held for trading has made an irrevocable election to present in other comprehensive income subsequent changes in the fair value of such equity instruments. Such an election is made by the Company on an instrument-by-instrument basis at the time of initial recognition of such equity investments.

Financial asset not measured at amortised cost or at fair value through other comprehensive income is carried at fair value through the statement of profit and loss.

Impairment of financial assets

Loss allowance for expected credit losses is recognised for financial assets measured at amortised cost and fair value through other comprehensive income. The Company recognises lifetime expected credit losses for all trade receivables that do not constitute a financing transaction. For financial assets whose credit risk has not significantly increased since initial recognition, loss allowance equal to twelve months expected credit losses is recognised. Loss allowance equal to the lifetime expected credit losses is recognised if the credit risk on the financial instruments has significantly increased since initial recognition.

De-recognition of financial assets

The Company de-recognises a financial asset only when the contractual rights to the cash flows from the asset expire, or it transfers the financial asset and substantially all risks and rewards of ownership of the asset to another entity. If the Company neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Company recognises its retained interest in the assets and an associated liability for amounts it may have to pay. If the Company retains substantially all the risks and rewards of ownership of a transferred financial asset, the Company continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.



(b) Financial liabilities and equity instruments

Classification as debt or equity

Financial liabilities and equity instruments issued by the Company are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument. An equity instrument is any contract that evidences a residual interest in the assets of the Company after deducting all of its liabilities. Equity instruments are recorded at the proceeds received, net of direct issue costs.

Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of the Company after deducting all of its liabilities. Equity instruments are recorded at the proceeds received, net of direct issue costs.

Financial Liabilities

Trade and other payables are initially measured at fair value, net of transaction costs, and are subsequently measured at amortised cost, using the effective interest rate method where the time value of money is significant.

Interest bearing bank loans, overdrafts and issued debt are initially measured at fair value and are subsequently measured at amortised cost using the effective interest rate method. Any difference between the proceeds (net of transaction costs) and the settlement or redemption of borrowings is recognised over the term of the borrowings in the statement of profit and loss.

The company has provided for accrued interest on loans taken from bank (Now assigned to UVARC Limited) in its books of accounts during the year as the accounts have been declared NPA by the respective lenders.

De-recognition of financial liabilities

The Company de-recognises financial liabilities when, and only when, the Company's obligations are discharged, cancelled or they expire.

Derivative financial instruments and hedge accounting

No such transaction has been undertaken by the company

2.8 BORROWING COST

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for the intended use or sale. Other borrowing costs are amortised / charged to Profit & Loss Account.

2.9 EMPLOYEE BENEFITS

Defined contribution plans

Payments to defined contribution plans are charged as an expense as they fall due. Payments made to state managed retirement benefit schemes are dealt with as payments to defined contribution schemes where the Company's obligations under the schemes are equivalent to those arising in a defined contribution retirement benefit scheme.

Defined benefit plans

For defined benefit retirement schemes the cost of providing benefits is determined as per Gratuity Act.

Compensated absences

Compensated absences which are not expected to occur within twelve months after the end of the period in which the employee renders the related service are recognised based on actuarial valuation at the present value of the obligation as on the reporting date.

2.10 INVENTORIES

Inventories are valued at the lower of cost and the net realisable value after providing for obsolescence and other losses, where considered necessary. Cost of inventories includes all costs and overheads in bringing the inventories to their present condition. Cost is arrived at moving weighted average basis. Work-in-process and finished goods include appropriate proportion of overheads.

Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and cost necessary to make sale.

2.11 PROVISIONS, CONTINGENT LIABILITIES

Provisions are recognised in the balance sheet when the Company has a present obligation (legal or constructive) as a result of a past event, which is expected to result in an outflow of resources embodying economic benefits which can be reliably estimated. Each provision is based on the best estimate of the expenditure required to settle the present obligation at the balance sheet date. Where the time value of money is material, provisions are measured on a discounted basis.

No provision has been made for contingent liability, they have been disclosed by way of notes.

2.12 ONEROUS CONTRACTS

A provision for onerous contracts is recognised when the expected benefits to be derived by the Company from a contract are lower than the unavoidable cost of meeting its obligations under the contract. The provision is measured at the present value of the lower of the expected cost of terminating the contract and the expected net cost of continuing with the contract. Before a provision is established, the Company recognises any impairment loss on the assets associated with that contract.

2.13 GOVERNMENT GRANTS & SUBSIDY

Grants received from the government agencies against specific fixed assets are adjusted to the cost of the assets and capital grants for project capital subsidy are credited to capital reserve. Revenue grants are recognized as other income or reduced from the respective expenditure. Grants & Subsidy are accounted for once the claims are admitted by the appropriate authorities. No Government Grants or subsidy has been received by the company during the year.

2.14 INCOME TAXES

Tax expense for the year comprises current and deferred tax. The tax currently payable is based on taxable profit for the year. Taxable profit differs from net profit as reported in the statement of profit and loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Company's liability for current tax is calculated using tax rates and tax laws that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is the tax expected to be payable or recoverable on differences between the carrying values of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit and is accounted for using the balance sheet liability method. Deferred tax liabilities are generally recognised for all taxable temporary differences. In contrast, deferred tax assets are only recognised to the extent that it is probable that future taxable profits will be available against which the temporary differences can be utilised.

The carrying value of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised based on the tax rates and tax laws that have been enacted or substantially enacted by the end of the reporting period. The measurement of deferred tax



liabilities and assets reflects the tax consequences that would follow from the manner in which the Company expects, at the end of the reporting period, to cover or settle the carrying value of its assets and liabilities.

Deferred tax assets and liabilities are offset to the extent that they relate to taxes levied by the same tax authority and there are legally enforceable rights to set off current tax assets and current tax liabilities within that jurisdiction.

Current and deferred tax are recognised as an expense or income in the statement of profit and loss, except when they relate to items credited or debited either in other comprehensive income or directly in equity, in which case the tax is also recognised in other comprehensive income or directly in equity.

Deferred tax assets include Minimum Alternate Tax (MAT) paid in accordance with the tax laws in India, which is likely to give future economic benefits in the form of availability of set off against future income tax liability. MAT is recognised as deferred tax assets in the Balance Sheet when the asset can be measured reliably and it is probable that the future economic benefit associated with the asset will be realised.

2.15 REVENUE RECOGNITION

Revenue is recognized only when it can be reliably measured and it is probable that the economic benefits will flow to the company and the revenue can be reliably measured, regardless of when the payment is being made. Revenue is measured at the fair value of the consideration received or receivable net of discounts.

Revenue from sale of goods is recognised when the significant risks and rewards of ownership have been transferred to the buyer. Interest income is recognized on time proportion basis taking into account, the amount outstanding and rate applicable.

30. Burnpur Cement Limited underwent a scheme of arrangement for reduction of share capital in accordance with the scheme filed on 06.06.2020 with NCLT, Kolkata Bench. The scheme was duly approved by the Hon'ble Bench of the National Company Law Tribunal (NCLT), Kolkata, on 30.10.2024. Subsequently, a copy of the order was filed with the Registrar of Companies, Kolkata, in compliance with the provisions of Companies Act, 2013.

The Registrar of Companies, Kolkata, has issued a fresh certificate consequent to the reduction of capital, adjusting the capital from Rs. 86,12,43,630 divided into 8,61,24,363 Equity Shares of Rs. 10 each, fully paid-up, to Rs. 17,22,48,730 divided into 1,72,24,873 Equity Shares of Rs. 10 each, fully paid-up. The Company has received Listing Approval from both the Stock Exchanges and also completed its Corporate action process. presently the Company has applied for trading approval of the above listed shares with both the Stock Exchanges. The applications are currently under process at the respective Exchanges, and approvals are awaited.

31. The Secured financial liabilities which has been classified as NPA by SBI, CBI & SBH is being transferred to UVARC Limited (*A securitisation/reconstruction company registered with RBI*) "as and where" basis as per SARFAESI Act, 2002. The interest of Rs.6592.11Lacs (Related to UVARCL) provided in the books as per the rate mentioned in loan agreement entered into between company and consortium lenders.

32. Notes on Going Concern assumptions :

Nature of the Business and Recent Developments

Burnpur Cement Limited is a manufacturing company. Over the past 8 years, since 2015, it is pertinent to tell that, the company has been declared as NPA back in December 2016. There were four secured financial creditor of the company i.e. State Bank of India, Central Bank of India, United Bank of India and West Bengal Financial Corporation. As stated above, West Bengal Financial Corporation has realised its debt by selling the assets of the Asansol Plant. Further, Central Bank of India, State Bank of India and Punjab National bank (Formerly known as United bank of India) via their letter dated 08.04.2019, 17.05.2019 and 11.08.2022 respectively assigned their parts of the secured debts of the company under section 5 of SARFAESI Act, 2002 to UV Asset Reconstruction Company Limited (**letters of Assignment attached**). **UV Asset Reconstruction Company Limited the acting Asset Reconstruction Company to Burnpur Cement Limited under Securitisation and Reconstruction of Financial Assets and Enforcement of Securities Interest Act, 2002, who has taken over 100% of the total secured debts of the Company has taken over the management of the Company in exercise of power under section 9(1)(a), 15 and 16 of SARFAESI Act, 2002 and clause 7(B) of RBI Circular bearing Reference No. RBI/2015-16/93 DNBR (PD) CC.No.04./SCRC/26.03.001/2015-16 dated 01.07.2015 with effect from 1st October 2019.** UV Asset Reconstruction Company Limited has appointed their representatives on the **Board of Directors with effect from 1st October 2019** and now the management of the company has been running by their representatives to realise their debts from the company.

Furthermore, The Company was in an offtake agreement with Ultratech Cement Limited ("Ultratech") by virtue of which the company was selling its entire finished products to Ultratech and the impact of demand and supply of Ultratech directly affected the performance of the company. Further on November 29,2023, M/s UV Asset Reconstruction Company Limited ("UVARCL"), by exercising their powers conferred to them under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 read with Security Interest (Enforcement) Rules,

2002, had by an auction process sold the entire immoveable and moveable assets of the Company situated at Patratu to M/s Ultratech Cement Limited for a total consideration of Rs. 169.79 Crores. The said amount of Rs. 169.79 Crores has been adjusted against the outstanding loan account balance standing in the books of the Company in the name of UVARCL. Hence, company has no actual sales/turnover from 30th Nov, 2023 i.e, from the date of sale of moveable and Immoveable assets of the company.

These issues have resulted in substantial losses and cash flow constraints.

Determination of Not Going Concern

In light of these developments, the company's management has assessed the company's ability to continue as a going concern and the accounts of the company has been prepared on the assumption that the company is not a going concern and further is has concluded that it is not reasonably likely to meet its obligations in the normal course of business over the next 12 months. The assessment was based on the following factors :

- Company do not have any functional production unit
- Significant recurring losses from operations
- Negative cash flows from operations
- Negative net worth or significant deficiencies in working capital
- Inability to secure additional financing
- Challenges in meeting financial covenants or loan obligations

Conclusion

In summary, the determination that **Burnpur Cement Limited** is not a going concern has significant implications for the company's financial statements and business operations. Users of these financial statements should carefully consider the inherent risks and uncertainties associated with this determination.

33. On November 29,2023, M/s UV Asset Reconstruction Company Limited ('UVARCL'), by exercising their powers conferred to them under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 read with Security Interest (Enforcement) Rules, 2002, had by an auction process sold the entire immoveable and moveable assets of the Company situated at Patratu to M/s Ultratech Cement Limited. Consequent to sale of all the operational assets, Company's do not have any operational/functional unit at present.
34. Figures pertaining to previous year have been re-grouped/re-arranged, reclassified and restated, wherever considered necessary, to confirm to the classification adopted in the current year.
35. There were no Foreign exchange inflow and outflow during the year.
36. In terms of Section 22 of Micro, Small & Medium Enterprises Act 2006, the outstanding to these enterprises are required to be disclosed. However, these enterprises are required to be registered under the Act. In the absence of the information about registration of the enterprises under the above Act, the required information could not be furnished. In view of above and in absence of relevant information, the auditor has relied upon the same.



37. The Company has defined gratuity plan. Every employee who has completed 5 years or more of service is entitled to gratuity on terms not less favorable than the provisions of the Payment of Gratuity Act, 1972. The amount of contribution to be made is arrived at the balance sheet date, as given below and is accounted accordingly :

38. Advances, Trade Payables and Trade Receivables are subject to confirmation from respective parties and consequential reconciliation, adjustment arising therefrom, if any. The management however does not expect any material variations. Provisions wherever considered necessary have been made.
39. In the opinion of the management, the current assets, loans and advances have a value on realization in the ordinary course of business, which is at least equal to the amount at which they are stated.
40. It is noted that a significant change in the ownership structure and related party relationships of our company. On 21.02.2023, the share pledged by the previous promoters was transferred to UVARC Limited. Consequently, in accordance with Ind AS-24 pertaining to related party disclosure, UVARC Limited is now considered a related party and is reflected accordingly in the corresponding head.
41. Some old bank accounts having balances of total of Rs 43.44 lacs, pertaining to the tenure of old management (Promoter management) and the account has a hold as per order of Sales Tax Department of Asansol.
