This is in continuation to our earlier disclosure dated 30-08-2025, wherein the Company had informed about the levy of penalty of Rs. 1,55,760/- imposed by National Stock Exchange of India Limited for non-compliance with provisions of Regulation 17(1A) of the SEBI (LODR) Regulation 2015 in connection with the quarter ended June 2025.

In this regard, we wish to inform you that the said Stock Exchange, vide its communication dated 20th March 2026, has reversed/withdrawn the aforesaid penalty. A copy of communication received from National Stock Exchange of India Limited is enclosed herewith.

Accordingly, the penalty of Rs. 1,55,760/- stands nullified.
